## Tuition Schedule 2021-2022

Preschool	\$6,000	N/A	Total \$6,000 = \$500 per month
Kindergarten-4th	\$5,300	\$500	Total \$5,800 = \$483 per month
5th-6th	\$5,300	\$800	Total \$6,100 = \$508 per month
7th-8th	\$5,400	\$800	Total \$6,200 = \$525 per month
9th-12th	\$5,700	\$800	Total \$6,500 = \$542 per month

The total (for tuition and books/activity fees combined) is reflected in the monthly payment.

Annual Payments are to be paid through FACTS. Annual payments received by June 20th will receive a 2% discount.

For Ohio EdChoice families, parents/guardians are responsible to pay any application fees, book/activity fees, incidental fees, and any balance of tuition not covered by a scholarship.

The child in the highest grade level within the family pays full tuition.

There is a \$500 discount for each additional child within the family.

### Special Fees

**Application Fee** \$200 (includes a \$25 testing fee)

**Re-Enrollment Fee** \$100 (\$150 after February 1st)

All special fees are **NON-REFUNDABLE** and are per student.

Annual, semi-annual, monthly, and bi-weekly payments are handled through FACTS via automatic withdrawals from your financial institution enabling you to manage your family's tuition payments conveniently and flexibly online.

## **LCA TUITION POLICY**

At Liberty Christian Academy we are committed to good stewardship. It is our goal to provide each child with the highest level of education at an affordable price. With multi-student discounts and financial aid opportunities, a quality Christian education may be more affordable than you think.

1. Tuition may be paid annually, semi-annually, monthly or bi-weekly through FACTS. There is a 2% discount on tuition if full payment is received by June 20th.
2. By default, all tuition accounts are on a 12-month payment schedule (June-May) and payable through FACTS. Failure to keep payments current will necessitate student withdrawal.
3. There is a \$500 discount for each additional child within the family. The child in the highest grade level within the family pays full tuition.
4. Book/Activity Fees are charged per student and are non-refundable.
5. Re-Enrollment fees will be paid through online enrollment in January. This fee holds the student's place for the upcoming school year. Please note that this fee will increase to \$150 on February 1st.
6. Checks made out to LCA and returned for insufficient funds will result in a \$25.00 service charge.
7. A student is considered enrolled and chargeable until notice of withdrawal has been received from a parent or guardian. Students attending any number of days in a month will owe tuition for the whole month. With the exception of Annual Payments, any paid tuition is non-refundable.
8. Students will not be placed on a class list and will not be able to attend until the previous year's account is paid in full. If fees remain unpaid by September 1st, the student will be officially withdrawn.
9. Report cards and transcripts are released if there is no outstanding balance on the account.

### **EXTENDED CARE**

Before and after school Extended Care fees are \$9 per family per session. These fees are due upon receipt of monthly invoice. The privilege of Extended Care may be revoked if the account is not kept current. A \$30 fee will be assessed for any late pick-up after 6:00 PM.

### **SCHOLARSHIPS**

LCA accepts the Ohio EdChoice Scholarship and the Ohio EdChoice Expansion Scholarship. Parents/Guardians are responsible to pay any application fees, book/activity fees, incidental fees, and any balance of tuition not covered by a Scholarship. Families must first complete the LCA online re-enrollment process before Ohio EdChoice renewal paperwork can be processed.

### **PARENT/GUARDIAN RESPONSIBILITY**

We bill only the student's legal guardian (or custodian) for school fees. In most cases, the legal guardian is the parent in whose home the student resides. In divorce cases where there is joint custody of the student, the parent who signed the enrollment application is responsible for the payment.

### **REFERRAL CREDIT**

You will receive a \$250 credit when a family enrolls that you have referred to LCA. This credit will be given after the new student has been enrolled for one academic quarter. As a referring family you will receive communication regarding how you would like your credit applied.
